## **AKBFF Mission Statement**

In 2022, the United States and Republic of Korea celebrated the 140th anniversary of diplomatic ties and, in 2023, noted the 70th anniversary of the Korea-US Mutual Defense Treaty. The relationship between the two countries has become closer and stronger now than ever. The relationship has grown to bind the two countries with inseparable ties, which is unprecedented in the history of relationships between any two countries. Cooperation between Korea and the US in bilateral and multilateral trade is noteworthy and remarkable. As many are aware, Korea was once one of the poorest countries in the world and went through a horrible internecine war. However, because of the diligence and hard work of its people, Korea has now joined the economically developed countries and is enjoying the fruits of its prosperity.

With this background, there is a growing need to further strengthen this strong economic relationship by informing the future generations of both countries of these strong ties and encouraging them to maintain the tradition even more. It is essential that the governments as well as the businesspersons, who have contributed greatly to the economic development of the two countries, promote mutual friendship and make efforts to find a way for industrial coexistence and co-prosperity in the rapidly changing global economic environment.

One noteworthy fact in this relationship is that exchanges and fellowship flow naturally among big companies and their leaders. But that is not the case for small and medium-sized businesses. The time is ripe to foster an organization that would promote exchange and friendship of small and medium-sized businesses and their leaders between the two countries. Considering that Korean American Businessmen Friendship Forum (KABFF) was established already and actively working in Korea for this purpose, it is desirable to establish a US counterpart to the Korean organization.

In February of 2023, AKBFF was formed with the following mission:

#### Develop and Promote Friendship and Fellowship between small and medium-sized businesses of the United States and Republic of Korea.

We hope AKBFF, in striving to achieve its mission, will become an essential and important bridge to the businesses of these two countries and contribute to their ever-stronger economic ties and relationship. Thank you for joining us in this endeavor!

Senator Mark Warner US Senator (Virginia)

Former Governor of Virginia

Member of the Democratic Party **Senator Mark Warner** began his career as a staff member on Capitol Hill before cofounding Columbia Capital, a firm instrumental in the growth of the cellular telephone industry in the 1980s and 1990s. His business success set the stage for his political career.

Senator Warner graduated from The George Washington University with a Bachelor's degree in Political Science and earned his Juris Doctor from Harvard Law School. Elected as the 69th Governor of Virginia, he served from 2002 to 2006, focusing on fiscal management, education reform, and technology initiatives. His pragmatic leadership and ability to work across party lines earned him a strong reputation.

In 2008, Warner was elected to the U.S. Senate, where he has been a prominent voice on technology, national security, and fiscal responsibility. He serves on the Senate Finance Committee, the Senate Banking, Housing, and Urban Affairs Committee, and as Vice Chairman of the Senate Intelligence Committee.

As Governor, Warner guided Virginia through a severe budget crisis, implementing costcutting measures while preserving essential services. In the Senate, he has been a key player in advancing bipartisan legislation and advocating for innovation and cybersecurity. Senator Warner is married to Lisa Collis, and they have three daughters. The family resides in Alexandria, Virginia. He is also known for his philanthropic efforts, particularly those aimed at improving education and expanding access to technology.

**Senator Tim Kaine** US Senator (Virginia)

Former Governor of Virginia

Member of the Democratic Party



**Senator Tim Kaine**, a Democrat from Virginia, has served in the U.S. Senate since January 2013. Born on February 26, 1958, in Saint Paul, Minnesota, he grew up in Kansas City, Missouri. Kaine graduated from the University of Missouri with a degree in economics in 1979 and earned his J.D. from Harvard Law School in 1983.

Kaine's political career began on the Richmond City Council from 1994 to 2002, including a term as mayor from 1998 to 2001. He served as Virginia's Lieutenant Governor from 2002 to 2006 and then as Governor from 2006 to 2010, focusing on education, job creation, and infrastructure.

In the Senate, Kaine serves on the Armed Services, Budget, Foreign Relations, and Health, Education, Labor, and Pensions (HELP) Committees. He advocates for a strong national defense, diplomacy, human rights, healthcare reform, education, and immigration policy improvements.

Kaine was Hillary Clinton's running mate in the 2016 presidential election, raising his national profile. Fluent in Spanish from his missionary work in Honduras during law school, Kaine is known for his public service commitment and efforts to bridge political divides. He resides in Richmond, Virginia, with his wife, Anne Holton, and they have three children.

Sarah Ahn Economic Minister Embassy of the Republic of Korea (Washington, D.C.) **Sarah Ahn** is a Korean diplomat currently serving as Economic Minister at the Embassy of the Republic of Korea in Washington, DC since February 2024. Before starting her second tour in the United States, she was Director-General for International Economic Affairs (2022-2024) in Seoul, in which capacity she oversaw Korea's participation in multilateral fora such as G20, APEC, OECD, and WEF (World Economic Forum).

Earlier in her career she was heavily involved in FTA negotiations including the KORUS FTA. During the first tour to the United States from 2007-2009, as First Secretary, she was engaged in a wide range of efforts to gain Congressional support for the ratification of the KORUS FTA. She later served as Director for the North American and European Union Economic Affairs Division in the Bilateral Economic Affairs Bureau from 2013-2014.

After joining the Foreign Service in 1997, she assumed overseas assignments including: the Embassies in the Republic of El Salvador (2009-2012) and the Federal Republic of Germany (2016-2018) and the Consulate General in Chennai, India (2014-2016).

She received her J.D. from Columbia Law School and her Bachelor's degree from Yonsei University.



**Prof. Kye Woo Lee** Former Professor of Economics/Executive of the World Bank Group

**Professor Kye Woo Lee** is an accomplished economist, academic and former World Bank Executive. He served as an economics professor and Managing Director of the Development Education and Research Network at KDI School of Public Policy and Management in Seoul. Additionally, he was a Chair Professor at Hankuk University of Foreign Studies and taught at Seoul National University and Ewha Womans University's Graduate Schools of International Studies. Professor Lee was also a visiting scholar at Princeton University's Woodrow Wilson School.

In government and advisory roles, he contributed as a civilian member of the Prime Minister's Committee on International Development Cooperation and advised various Korean ministries and organizations. His leadership extended to serving as Chairman of the Hanse Yes24 Cultural Foundation and a board member of Ewha Womans University Scholarship Foundation.

Before returning to Korea in 1998, Professor Lee had a significant career at the World Bank in Washington, DC, earning the Presidential Award for Excellence in Project Outcomes in 1997. He also served as an advisor for Korea's Fifth Five-Year Economic Plan in 1981. Professor Lee has an extensive publication record, and has written books and numerous articles on international trade, finance, and economic development. He has also served as President of the Korean Economic Society in the United States.



**Sangkuen Park** (박상근) Partner, Moon, Park & Associates

AKBFF Board of Directors Sang K. Park is a graduate of Seoul National University College of Law (1979) and its law school with LL.M. in International Law (1981). Mr. Park came to the US in 1981 and graduated from George Washington University, National Law Center with LL. M. in Comparative Law (1983) and International Law (1985). Having been a member of District of Columbia (1988), Virginia (1989) and Maryland State Bars (1992), his primary practice is in the area of commercial real estate transactions, landlord and tenant law, labor law, immigration law and conflicts of law between US and Korea. He has been associated with several title insurance companies as a transactional attorney for the past fifteen years. In helping Korean community to be assimilated into mainstream society, he served for fifteen years as a legal counsel for Korean American Association of Washington Metropolitan Area and for Korean American Grocers' Association of Greater Washington. As an advocate for political and social empowerment of Korean Americans, he was one of the founders of Advocates for the Rights of Korean Americans, an advocacy organization supported by 1st and 2nd generation Korean immigrants, and later served as its executive director. In public arena, Mr. Park served as a member of Advisory Committee to Immigrant and Refugee Policy Council under Virginia General Assembly and was a member of Fairfax County Human Rights Commission from 1999 to 2001. In 2018, he finished the term as the President of Korean CBMC (Connecting Business and Marketplace to Christ) of North America that represents Korean Christian businessmen and professionals in North America.

Mr. Park has been a partner of the law firm, Moon, Park & Associates located in Annandale, Virginia, since 1992.



**Sunshik Min, PhD** (민선식) Chairman & CEO, YBM

**Dr. Sunshik Min** is the CEO/Chairman of YBM. The company and its subsidiaries publish books and magazines, including the Korean edition of National Geographic Magazine, and administer language-proficiency and IT-skills tests. They also operate language schools for children and adults. Dr. Min is the head of the Korea International School (KIS). Founded in 2000, KIS offers a K-12 English-medium curriculum at three campuses and is fully accredited by the Western Association of Schools and Colleges (WASC) in the United States.

Dr. Min is actively involved in activities of not-for-profit organizations including the Korean American Businessmen's Friendship Forum (KABFF), Harvard University, the Massachusetts Institute of Technology, and the Korea Britain Society. He received the Medal of Industrial Merit from the Korean government and was appointed an Officer of the Order of the British Empire (OBE).

Dr. Min received a Bachelor's degree in Economics from Seoul National University, a Master's degree in Management from MIT, and a Doctoral degree in Business Administration from Harvard University. Dr. Min has served as a lecturer and adjunct professor at several universities in Korea, Singapore, and Japan.

**Dr. Hyun-jung Je** is the Chief Representative of KITA Washington Center for the Korea International Trade Association. She is currently in charge of advising and supporting Korean trade companies which are involved in trade and investment issues in the U.S. and also plays a key bridging role connecting Korean businesses and the US government, Congress and think tanks.

Since she joined KITA in 2001, she has worked as a researcher for most of her career years at the Institute for International Trade (IIT), a branch of KITA. She published numerous research and policy papers focusing on Korea's trade policies, free trade agreements and diverse trade issues involving Korean companies. From 2016 to 2018, she served as a private advisor for trade negotiations in the Ministry of Foreign Affairs and Trade and participated in the negotiations on market access during the Korea-US, Korea-Canada and the Korea-India FTAs. From 2020 to 2021, she also served as a member of the Presidential Commission on Policy Planning.

Based on her own experiences and academic research, she published a book entitled "<u>Public-Private Relationships in Trade Policy-making</u>" in 2018. Dr. Je holds a Ph.D. in International Studies (major in International Commerce) and a B.A. and M.A. in International Relations from Seoul National University.




Jaehan Park Founder & CEO NAUGEN, Inc.


